Welcome

- 1 Legislative Update
 - Cammie Chapman provided an overview from the legislative session.
 - House Bill 2006 implements a division within DHHR effective January 1, 2024.
 Bureaus/offices will be divided as follows.
 - Department of Health
 - Bureau for Public Health (BPH)
 - Office of Emergency Medical Services
 - Office of the Chief Medical Examiner
 - Center for Threat Preparedness
 - Health Care Authority
 - Office of Inspector General
 - Human Rights Commission
 - o Department of Human Services
 - Bureau for Social Services (BSS)
 - Bureau for Medical Services (BMS)
 - Bureau for Child Support Enforcement
 - Bureau for Family Assistance
 - Bureau for Behavioral Health (BBH)
 - Office of Drug Control Policy
 - Department Health Facilities
 - Oversees DHHR-owned hospitals
 - Yet to be designated to a department
 - Commission for the Deaf and Hard of Hearing
 - Women's Commission
 - Developmental Disabilities Council
 - JTM Catastrophic Illness Commission

- Family Protection Services Board
- Commission to Study Residential Placement of Children
- There will be an office of shared administration.
- This is a positive change that will allow secretaries to have a narrower focus.
- House Bill 2018 permits Managed Care Organizations (MCOs) to attend multidisciplinary team (MDT) meetings.
- House Bill 3061 expands authority of the Foster Care Ombudsman.
- Senate Bill 273 formally creates BSS, requires staffing allocations for Child Protective Services (CPS), requires reporting procedures for centralized intake, exempts BSS from the Division of Personnel, and requires certain statistics to be placed on the Child Welfare Data Dashboard.
- House Bill 3261 provides authority to hire certain retirees and individuals with an associate degree in a pilot program in Judicial Districts 23 and 14.
- House Bill 2016 allows Child-Placing Agencies (CPAs) to request birth certificates from Vital Statistics and clarifies confidentiality with referrals.
- H2875 allows for children to be placed with grandparents without home study.
- House Bill 2917 allows BSS to hire retired state workers.
- Senate Bill 647 provides a ceiling on certain substantiations of findings of abuse and neglect allegations.
- House Bill 3439 limits civil liability for child welfare agencies.

2 WV DHHR Semiannual Quality and Outcomes Report – January 2023

- Laura Hunt said this will be the third report and said DHHR is seeing positive change with implementation. The report can be found on the Kids Thrive website: kidsthrive.wv.gov

3 CSED Waiver Update

- Laura said provider enrollment continues to be a focus. The number of agencies participating in the program has increased from 12 to 19 with an additional 10 agencies in the provider enrollment process.

4 Bringing Our Children Home

- Lorie Bragg said DHHR plans to reduce the number of children placed in out-ofstate (OOS) facilities. DHHR has met with other states for technical assistance (TA) to learn best practices. The team is working to identify service gaps to better serve youth.
- The goal is to reduce the number of OOS placements to 210 by end of year (EOY).

5 QIA Process

Lorie said DHHR has contracted with Kepro to conduct independent assessments

- and recommend the level of service each child needs.
- Lorie said DHHR began training staff in August 2022 on making referrals to the (QIA) process. DHHR is on target to have staff trained by the end of May. The expectation is that all children entering residential care will have had an assessment.

6 Discharge Planning Update

- Lorie said DHHR has been working with Aetna to review discharge barriers for children with a Child and Adolescent Functional Assessment Scale (CAFAS)/Preschool and Early Childhood Functional Assessment Scale (PECFAS) score under 90. It is important that discharge plans are not only in place, but appropriate. Every month, during the reauthorization process, the team will review discharge plans.

7 30-Day Reauthorization Process Update

- Brooke Boston said since October of 2022, providers have been completing
 monthly reevaluations for necessity with Aetna. At each reevaluation, the team
 reviews the discharge plans with a goal of moving children into a community-based
 setting as quickly as possible.
